**Subject:-** Grant of Renewal of Temporary Affiliation retrospectively for the Academic Sessions 2020-21, 2021-22, 2022-23 & 2023-24.

Sir,

*Pursuant to the report of the Inspection Committee dated April 16, 2024 and in anticipation of the approval of the competent body, the Vice Chancellor has been pleased to authorize to grant of renewal of temporary affiliation retrospectively in favour of Govt. Degree College, Bomai, Sopore for the academic session 2020-21, 2021-22, 2022-23 and for the current academic year 2023-24, subject to the fulfillment of the following conditions. The University is vested with the authority to withdraw the affiliation as per the relevant sections of the Kashmir & Jammu Universities Act 1969 and concerned statutes, if the college fails to meet the conditions laid down by the visiting inspection team of experts:-*

1. Seek the recruitment of faculty on Permanent basis atleast one for each subject for efficient teaching learning process.
2. Undertake the construction at college campus on war footing basis so that the requisite infrastructural facilities are made available to the students at the earliest.
3. Seek creation of faculty positions for all those courses for which no position stands created as on today. Besides, get the recruit of vacant positions done in the next 3 months positively.
4. Upgrade the existing science labs by added all the requisite equipments and other facilities immediately so the practical's are being done by the students without any constraint.

5. The College should shift library to new place having sufficient space, furniture and furnishing and a space for Reading Room. Besides, the Library should be fully automated using SOUL 2.0 or any other suitable software. The library should have:
  - Seating arrangement for atleast 60 students
  - Books 3000 (Minimum 50 copies for each title)
  - Journals 5 ( one third should be foreign and subscribed on continuous basis)
  - Reading Room with seating capacity for 20 students
  - Separate budget for the Library with atleast recurring expenditure of not less than
  - ICT facility for browsing online material.
  - Photocopying facility
  - Rooms for Librarian and other staff with intercom phone facility.
6. The college should shift the Computer Lab from the existing location at the earliest to some suitable place. The girls Common Room and Sick Room also should be upgraded with all the requisite facilities.
7. Immediately create safe drinking water facilities and install fire extinguishers and all the staff members be trained to use fire extinguishers. Besides separate toilet facility be created for specially-abled persons.
